- 3) Please insure that any overpayment claimed from a prior year return has not already been refunded by Spencer County to the business.
- 4) Please attach a copy of this completed extension request to the actual Spencer County, Kentucky, Net License Fee Return upon filing of the return.
- 5) Once approved, your extension request is for 6 months from the original filing due date.
- 6) This extension form extends the filing of the return but does not extend the time for paying the tax due.
- 7) Any tax not paid by the original due date will be subject to interest fees.
